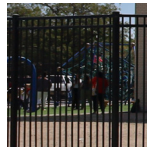
The Reagan County Independent School District Board of Trustees unanimously approved calling a School Bond Election for November 8. This bond was developed by a committee of community members in conjunction with the staff and administration. Their primary task was to develop and present to the Board of Trustees a long-term plan that included a recommendation for implementation.

A Proposition A

Safety & Security

PROPOSED: \$1.8 M

- District-wide safety and security upgrades at every school
- New surveillance cameras at all three campuses
- New access-card reader system at the Elementary
- Metal detectors at office entrances

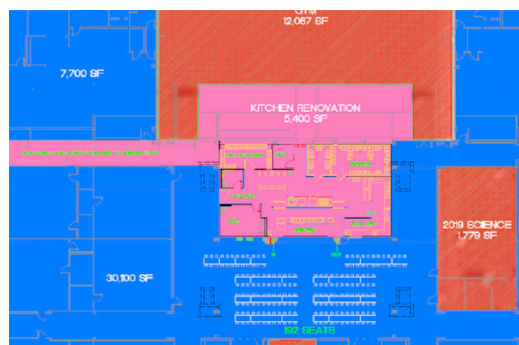


Renovations & Upgrades

PROPOSED: \$14 M

Middle School

Upgrades include a new kitchen, two new classrooms, new flooring, classroom renovations, and exterior renovations.



Elementary School Playgrounds

Parking Lot & ADA Accessibility Improvements

New Buses

PROPOSED: \$2 M

- RCISD activity buses travel 25,000 miles per year.
- Over one-third of the RCISD activity bus fleet is approaching or past its useful life.
- Purchase new charter buses and replace district vehicles.



Career & Tech Expansion

PROPOSED: \$20 M

Construct Career & Technology Success Center building with modern equipment and technology. The new CTE Success Center includes a culinary kitchen, metal shop, and agriculture classroom.



Athletic Upgrades

PROPOSED: \$28 M

- New HS competition gym with seating.
- New boys' and girls' locker rooms.
- New concession/restroom/ticket building and new locker rooms at baseball/softball.

B Proposition B

Teacher Housing

PROPOSED: \$4 M

- Due to the proximity to the oil & gas industry and the competition for human resources, the district provides teacher housing to be able to recruit and retain highly qualified teachers for classroom instruction.
- Current teacher houses are an average age of 20 years old and have had no investment since they were constructed/purchased.
- Proposition B includes upgrades like new siding, roofing, fences, carports, windows, flooring, kitchen and bathroom finishes and MEPS replacements for items past their useful life.

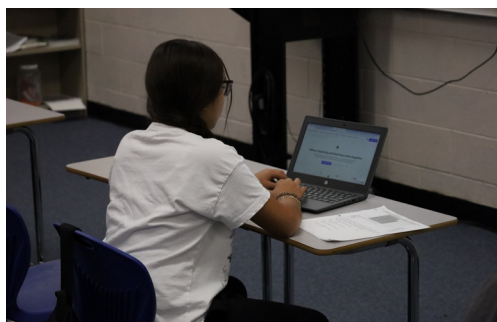


C Proposition C

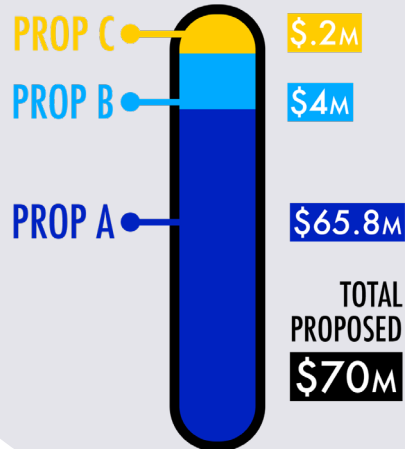
Technology

PROPOSED: \$200,000

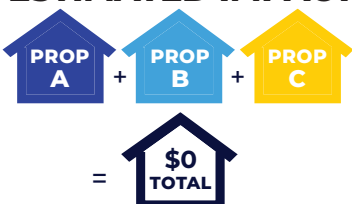

BALLOT LANGUAGE

In 2019, Texas Legislators passed a new law as part of HB 3 that requires all bond propositions for any school district to have the phrase "THIS IS A PROPERTY TAX INCREASE" on all ballot language for bond propositions. Due to this requirement, all voters will see this statement on the official ballot language, even if the tax dollar amount is frozen and will not exceed the tax ceiling.
